Rental Agreement Details

Terms, Rules, & Conditions

- Owner agrees to pay a monthly storage fee of \$ _____ plus H.S.T. payable monthly in advance for

_____ due on or before the _____ day of each month.

- It is the responsibility of the Owner to make payment on or before due date, a \$20.00 late payment fee will be applied to the account on the day following the due date. 30 day notice to vacate the premises may be issued following the 2nd occurrence. A 2% per month interest charge will be applied to any outstanding account balance. It is not the responsibility of the Storer to contact the Owner regarding overdue rent, if rent becomes 60 days overdue the property will be deemed abandoned and will be disposed of. The disposal and clean up cost will be added to the account for collections.
- A deposit is required equal to 1 month storage fee and will be refunded after the Owner moves out providing proper 30 day notice has been given and no damage or garbage is found.
- Storage fees are payable monthly in advance and are automatically renewed on a month to month basis and may be terminated with 30 days written / E-Mail notice by either the Storer or the Renter.
- Storage fees are not refundable.
- Owner will be notified at least 30 days in advance of rate increases by E-Mail or notice posted on stored property.
- Minimum 2 months rental agreement period
- The rental agreement is not transferable except with the approval of the Storer.
- Storage fees are for space only and no other services will be provided.
- The Storer carries no insurance covering the Owners goods / property and assumes no liability.
- The Owner agrees to a service charge of \$50.00 on any dishonored cheques.
- It is the responsibility of the Owner to update any changes of mailing / street address, E-Mail address or phone number to the Storer immediately.
- The Owner shall not store explosive or flammable goods or material, allow any noxious odour or liquid of any kind to escape from the storage area, do any act or thing which may disturb the quiet enjoyment of any other occupant, or of lands and premises nearby, use the storage area for any unlawful purpose, sublet or assign the right to store goods on the premises, store on the premises anything which shall be in violation of any order or requirement imposed by any Municipal, Provincial or Federal Authority, do any act or cause to be done any act on the premises which creates or may create a nuisance in connection with the premises, allow any refuse, garbage or other loose or objectionable material to accumulate on or about the premises.
- No mechanical work or painting to be done on facility property.
- The Owner has the sole responsibility to insure any goods or property.
- The Owner agrees that they assume all risks with respect to any goods or property.
- The Storer is not responsible for any loss or damage to the Owners goods or property resulting from water, gas, explosion, fire, wildlife, windstorm, collapse, theft or acts of God.
- The Owner hereby agrees to indemnify and hold harmless the Storer against any and all liability claims, damages arising from or in any way relating to this agreement, the rented property, including but not limited to damages for personal injuries of the Owner and their invitees.
